
ORDER AUTHORIZING QUALIFIED REPRESENTATIVE STATUS

On March 14, 2005, Jay Molyneaux, Attorney for Florida Power and Light Company (FPL), filed a written request pursuant to Rule 28-106.106, Florida Administrative Code, for Stephen L. Huntoon, Senior Attorney for FPL, to appear as Qualified Representative for FPL in all docketed and undocketed matters before this Commission until January 31, 2006. Upon review, it appears that Stephen L. Huntoon has the necessary qualifications to responsibly represent FPL's interests in a manner that will not impair the fairness of any proceeding involving the company or the correctness of the action to be taken. Having met the requirements of Rule 28-106.106(4), Florida Administrative Code, Stephen L. Huntoon is authorized to appear as Qualified Representative on behalf of FPL in any undocketed or docketed matter opened by January 31, 2006.

Based on the forgoing, it is

ORDERED by Chairman Braulio Baez, as Presiding Officer, that Stephen L. Huntoon, Senior Attorney, 801 Pennsylvania Avenue, N.W., Suite 220, Washington, DC 20004, is hereby authorized to appear as Qualified Representative on behalf of Florida Power and Light Company, for any undocketed or docketed matter opened during the next twelve months ending January 31, 2006.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
