NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELING ALTERNATIVE ACCESS VENDOR CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Teligent Services, Inc. (Teligent), holder of Alternative Access Vendor (AAV) Certificate of Public Convenience and Necessity No. 4707, has requested the cancellation of AAV Certificate No. 4707. Teligent has complied with the provision of Rule 25-24.735(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its AAV certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2004 and 2005. Accordingly, we find it appropriate to cancel AAV Certificate No. 4707, effective March 10, 2005. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Teligent Services, Inc.'s Certificate No. 4707 to provide Alternative Access Vendor services is hereby canceled, effective March 10, 2005. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak


