NOTICE OF PROPOSED AGENCY ACTION  
ORDER CANCELLING COMPETITIVE LOCAL EXCHANGE  
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Global Metro Networks Florida, LLC, holder of Competitive Local Exchange Telecommunications Certificate (CLEC) of Public Convenience and Necessity No. 7729, has requested the cancellation of CLEC Certificate No. 7729. Global Metro Networks Florida, LLC has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its CLEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the years 2004 and 2005. Accordingly, we find it appropriate to cancel CLEC Certificate No. 7729, effective August 1, 2005. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Global Metro Networks Florida, LLC's Certificate No. 7729 to provide Competitive Local Exchange Telecommunications services is hereby canceled, effective August 1, 2005. It is further
