NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

By a letter dated June 27, 2006, Global Internetworking, Inc. and Mercator Partners Acquisition Corp. filed with this Commission an application for approval of transfer of control from Global Internetworking, Inc., to Mercator Partners Corp. Global Internetworking, Inc. is holder of Certificate No. 8512.
