ORDER GRANTING FLORIDA POWER & LIGHT COMPANY'S
MOTION FOR TEMPORARY PROTECTIVE ORDER

On August 23, 2006, Florida Power & Light Company ("FPL") filed a Motion for Temporary Protective Order, pursuant to Rule 25-22.006(6), Florida Administrative Code, covering certain documents sought in discovery by the Office of Public Counsel ("OPC"). FPL requests that documents produced in its response to numbers 2 and 4 of OPC's First Request for Production of Documents be protected from disclosure. The utility seeks exemption from Public Records Law, Section 119.07(1), Florida Statutes, for those documents. No party filed a response to FPL's motion.

FPL asserts that its response to number 2 of OPC's First Request for Production of Documents requests FPL to produce information regarding the damage to, and subsequent leak in, the pressurizer piping at Turkey Point Unit 3. FPL states that the damage appears to have been inflicted deliberately and is the subject of investigation by law enforcement agencies. FPL further states that for security reasons, this information is intended to be and is treated by FPL as private and has not been publicly disclosed.

FPL further states that its response to number 4 of OPC's First Request for Production of Documents requests backup documentation regarding FPL's Exhibit GJY-1, pages 1 through 39, to the prepared testimony of FPL witness Gerard J. Yupp (Document No. 02955-06) which was filed in this docket on April 3, 2006, and reports the 2005 results of FPL's fuel hedging program. In Order No. PSC-06-0564-CFO-EI, dated June 30, 2006, the Commission granted confidential classification to Exhibit GJY-1 finding that it appeared to contain information concerning bids or other contractual data, the disclosure of which would impair the efforts of FPL or its affiliates to contract for goods on favorable terms. Additionally, FPL contends that this information also relates to the competitive businesses of FPL and/or its counterparties, the disclosure of which would impair their competitive businesses.

FPL asserts that it is seeking protection of the documents as provided in Section 366.093(2), Florida Statutes, and Rule 25-22.006(6), Florida Administrative Code. FPL contends that by following this procedure it is not waiving its rights to seek further relief as necessary to make certain that this information is not publicly disclosed.

Section 366.093(2), Florida Statutes, directs that all records produced pursuant to a discovery request for which proprietary confidential status is requested shall be treated by any party subject to public records law as confidential and exempt from the public records law, Section 119.07(1), Florida Statutes. Rule 25-22.006(6), Florida Administrative Code, codifies

the Commission's policy protecting confidential information from public disclosure during the discovery process in a manner that is not overly burdensome to both parties. Rule 25-22.006, in pertinent part, states:

(6)(c) In any formal proceeding before the Commission, any utility or other person may request a protective order protecting proprietary confidential business information from discovery. Upon a showing by a utility or other person and a finding by the Commission that the material is entitled to protection, the Commission shall enter a protective order limiting discovery in the manner provided for in Rule 1.280, Florida Rules of Civil Procedure. The protective order shall specify how the confidential information is to be handled during the course of the proceeding and prescribe measures for protecting the information from disclosure outside the proceeding.


In addition, Rule 25-22.006(6)(c), Florida Administrative Code, states that if a party allows OPC to inspect or take possession of utility information, then that "utility may request a temporary protective order exempting the information from section 119.07(1), F.S."

Upon consideration, FPL's Motion for Temporary Protective Order is granted, to be consistent with the ruling above concerning which information is classified as confidential. Regarding the information for which confidential classification is granted, it appears that FPL has demonstrated that the material is proprietary confidential business information. Accordingly, this information will be protected from disclosure pursuant to Rule 25-22.006(6), Florida Administrative Code.

Based on the foregoing, it is

ORDERED by Commissioner Matthew M. Carter II, as Prehearing Officer, that the Motion for Temporary Protective Order filed by Florida Power & Light Company is granted.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
