NOTICE OF PROPOSED AGENCY ACTION  
ORDER CHANGING THE EFFECTIVE DATE OF THE CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On December 7, 2006, Acceris Management and Acquisition, LLC (Acceris) New Access Management LLC, and First Communications filed a joint petition for waiver of selection requirements of rule 25-4.118, FAC. The petition included a request to cancel Competitive Local Exchange Certificate No. 8371 and IXC Registration No. TK007 held by Acceris. The effective date of the original request was March 1, 2007. In a letter dated March 21, 2007, Acceris requested that the cancellation date be amended to reflect an effective date June 30, 2007. On April 24, 2007, the Commission approved the company's request to change the effective date of cancellation on the CLEC certificate No. 8371 to June 30, 2007.


Based on the foregoing, it is
