ORDER GRANTING MOTION FOR
EXTENSION OF TIME TO FILE TESTIMONY

Pursuant to Rule 25-17.015(1), Florida Administrative Code (F.A.C.), the Commission has set a hearing in its continuing Natural Gas Conservation Cost Recovery (GCCR) docket for November 6-8, 2007. By Order No. PSC-07-0168-PCO-GU, the Order Establishing Procedure, issued February 23, 2007, dates were established for a number of prehearing activities, including dates for the prefiling of testimony. According to that Order, the Utilities Projection Testimony and Exhibits were due on September 14, 2007. On September 13, 2007, FPUC filed a Motion for Extension of Time to File its projection testimony and exhibits (Motion).

In support of its Motion, FPUC states that it has had a variety of filings which were due at or about the same time as the testimony and exhibits in this docket. The staff responsible for the preparation and review of the filings in this docket are the same as for the other dockets and with the limited staff resources available, the process has experienced short delays. Therefore, FPUC has requested an extension to file its testimony on Wednesday, September 19, 2007. FPUC does not believe that the short extension will adversely affect staff or any other party to this docket. In addition, FPUC states that it would not object to any request for extension to submit rebuttal testimony equal to that granted to the utility.

Based on the foregoing, FPUC's request is reasonable and is hereby granted. FPUC's Projection Testimony and Exhibits shall be due on September 19, 2007.

Based on the foregoing, it is

ORDERED by Commissioner Matthew M. Carter II, as Prehearing Officer, that FPUC's Motion For Extension of Time to File Projection Testimony and Exhibits is granted. It is further

ORDERED that FPUC shall file its Projection Testimony and Exhibits by September 19, 2007. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
