NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.
