ORDER GRANTING GULF POWER COMPANY'S
REQUEST FOR CONFIDENTIAL CLASSIFICATION
(DOCUMENT NO. 03439-12)

On May 30, 2012, pursuant to Rule 25-22.006, Florida Administrative Code, Gulf Power Company (Gulf or Company) filed its request for confidential classification (Request) of "certain information produced by the Company in response to Commission Staff's Second Set of Interrogatories (Nos. 3-6). The Company asks that the Commission enter an order protecting the information from public disclosure.

Request for Confidential Classification

Section 366.093(1), Florida Statutes, provides that "any records received by the Commission which are shown and found by the Commission to be proprietary confidential business information shall be kept confidential and shall be exempt from Section 119.07(1) [the Public Records Act]." Pursuant to Section 366.093(3), Florida Statutes, proprietary confidential business information includes information that is intended to be and is treated by the company as private, in that disclosure of the information would cause harm to the company's ratepayers or business operations, and the information has not been voluntarily disclosed to the public. Confidential business information includes "contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms" and "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." *Id.* at d-e.

Gulf asserts that the identified information "is intended to be, and is treated as confidential by [the Company] and . . . has not otherwise been publicly disclosed." The information includes 1) data relating to the amounts of gypsum produced, disposed of and sold by Gulf and related costs and revenues, 2) the amount of gypsum produced, stored and sold at Plant Crist in 2010 and 2011 and associated revenues, 3) the storage capacity of the gypsum storage facility at Plant Crist, costs to construct the facility and useful life of the facility, and 4) annual gypsum production at Plant Daniel, the estimated annual cost of disposing of gypsum, and Mississippi Power Company's plans for marketing gypsum. Gulf argues that disclosure of the information could impair Gulf's efforts to market gypsum to the detriment of Gulf and its customers and provide potential purchasers of gypsum with an advantage in negotiations for the purchase and sale of gypsum. Based on the foregoing, the Company asserts that the information is entitled to confidential classification pursuant Section 366.093(3)(e), F.S.

Ruling

Upon review, I find that the information in Document No. 03439-12, identified more specifically in Exhibit C of the Request, is treated by the Company as private and is information relating to competitive interests, the disclosure of which would impair the competitive business of the provider. I find that disclosure of the identified information would cause harm to Gulf's ratepayers or to its business operations. Thus, the information shall be granted confidential classification pursuant to Section 366.093(3)(e), F.S.


Based on the foregoing, it is

ORDERED by Commissioner Eduardo E. Balbis, as Prehearing Officer, that Gulf Power Company's Request for Confidential Classification of Document No. 03439-12 is granted. It is further

ORDERED that the information, in Document No. 03439-12, for which confidential classification has been granted shall remain protected from disclosure for a period of 18 months from the date of issuance of this Order. At the conclusion of the 18-month period, the confidential information will no longer be exempt from Section 119.07(1), F.S., unless Gulf or another affected person shows, and the Commission finds, that the records continue to contain proprietary confidential business information. It is further

ORDERED that this Order shall be the only notification by the Commission to the parties of the date of declassification of the materials discussed herein.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
