ORDER AUTHORIZING APPEARANCE
AS QUALIFIED REPRESENTATIVE

In this order I grant a request made under Rule 28-106.106, Florida Administrative Code, that Thadeus B. Culley be designated as a qualified representative, authorized to represent before this Commission the interests of The Alliance for Solar Choice, even though he is not admitted to practice law in Florida.


In designating Thadeus B. Culley as a qualified representative, I have confirmed that the application conforms to the requirements of the rule and that, based on the information contained in the application, Thadeus B. Culley has the necessary qualifications to represent the interests of The Alliance for Solar Choice as contemplated under the rule. For example, this applicant is admitted to practice law in states other than Florida.

The qualified representative designation is reflected in the Appendix, which is incorporated as part of the body of this order.

Based on the foregoing, it is

ORDERED by Art Graham, as Presiding Officer, that the person identified in the Appendix to this order, Thadeus B. Culley, is hereby authorized to appear as Qualified Representative for The Alliance for Solar Choice.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
