ORDER GRANTING FLORIDA POWER & LIGHT COMPANY'S
THIRD REQUEST FOR CONFIDENTIAL CLASSIFICATION
(DOCUMENT NOS. 04702-2015 AND 07944-2015)

On June 30, 2020, pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), Florida Power & Light Company (FPL) filed its Third Request for Extension of Confidential Classification of documents contained in the Florida Public Service Commission (Commission) Staff's Review of Data Accuracy in Electric Reliability Reporting by Florida Electric IOUs. Specifically, FPL seeks extended confidential classification of Document Nos. 04702-2015 and 07944-2015.

Request for Confidential Classification

FPL's original request for confidential treatment of information was granted by Order No. PSC-15-0531-CFO-EI, issued on November 13, 2015. FPL's first request for extension of confidential classification was granted by Order No. PSC-17-0183-CFO-EI, issued on May 17, 2017. FPL's second request for extension of confidential classification was granted by Order No. PSC-2019-0011-CFO-EI, issued on January 2, 2019. FPL asserts that all of the information that was the subject of Order No. PSC-15-0531-CFO-EI and Order No. PSC-17-0183-CFO-EI warrants continued treatment as proprietary and confidential business information.

FPL contends that Document Nos. 04702-2015 and 07944-2015 contain certain information that constitutes "proprietary confidential business information" entitled to protection under Section 366.093, F.S., and Rule 25-22.006, F.A.C. FPL states that this information is intended to be and is treated by FPL as private and has not been publicly disclosed.

FPL further contends that Document Nos. 04702-2015 and 07944-2015 contain information concerning internal auditing controls and reports of internal auditors and asserts that this information is protected by Section 366.093(3)(b), F.S. Additionally, FPL asserts the documents contain information concerning contractual data and relating to competitive interests, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms and the competitive business of the provider of the information, and that this information is protected by Section 366.093(3)(d) and (e), F.S., respectively.

Ruling

Section 366.093(1), F.S., provides that records the Commission has found to contain proprietary business information shall be kept confidential and shall be exempt from Chapter 119, F.S. Section 366.093(3), F.S., defines proprietary confidential business information as information that is intended to be and is treated by the company as private, in that disclosure of the information would cause harm to the company's ratepayers or business operations, and has not been voluntarily disclosed to the public. Section 366.093(3), F.S., provides that proprietary confidential business information includes, but is not limited to:

- (b) Internal auditing controls and reports of internal auditors.
- (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.
- (e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information.

Upon review, it appears the above-referenced information satisfies the criteria set forth in Section 366.093(3), F.S., for classification as proprietary confidential business information. The information appears to be audit workpapers that contain internal auditing controls and reports of internal auditors, information concerning bids or other contractual data, and information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Thus, the information identified in Document Nos. 04702-2015 and 07944-2015 shall be granted confidential classification.

Pursuant to Section 366.093(4), F.S., the information for which confidential classification is granted herein shall remain protected from disclosure for a period of up to 18 months from the date of issuance of this Order. At the conclusion of the 18-month period, the confidential information will no longer be exempt from Section 119.07(1), F.S., unless FPL or another affected person shows, and the Commission finds, that the records continue to contain proprietary confidential business information.

Based on the foregoing, it is hereby

ORDERED by Commissioner Julie I. Brown, as Prehearing Officer, that Florida Power & Light Company's Third Request for Extension of Confidential Classification of the information contained in Document Nos. 04702-2015 and 07944-2015 is granted. It is further

ORDERED that the information in Document Nos. 04702-2015 and 07944-2015, for which confidential classification has been granted, shall remain protected from disclosure for a period of up to 18 months from the date of issuance of this Order. It is further

ORDERED that this Order shall be the only notification by the Commission to the parties of the date of declassification of the materials discussed herein. It is further

ORDERED that this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy.
