The purpose of this filing is to offer promotional credits to business customers who, during the promotional period, subscribe to a minimum one year term agreement for either Verizon Exchange service, Analog CentraNet Service, Verizon Long Distance plan, Verizon Online services, FiOS service, or a two year term agreement for CentraNet CustopaK Service, and who meet the minimum spend level per month for total billed revenue based on a 3 month average for Verizon services.

Customers who agree not to disconnect their dial tone service and satisfy the eligibility criteria will receive bill credits over a period of five (5) months.
