ORDERED that the Utility shall submit its Certificates to the Commission for amendment within 20 days of the date of this Order. It is further

ORDERED that the Utility shall charge the rates approved in its tariff to customers in the territory added herein. It is further

ORDERED that Docket No. 870109-WS is hereby closed.
