NOTICE OF PROCEDURES TO BE FOLLOWED AT RULEMAKING HEARINGI. Background

The Florida Public Service Commission has proposed a revision to Rule 25-14.003, F.A.C., and, after publication in the Florida Administrative Weekly, has received comments and requests for a hearing. The revision addresses repeal of the rule for the water and wastewater companies and a change in the reporting date.

A hearing is scheduled to take place at 9:30 a.m. on September 22, 1989. The hearing will be held in Room 106 of the Fletcher Building, 101 East Gaines Street, Tallahassee, Florida.

II. Rulemaking Hearing

A rulemaking hearing is governed by Section 120.54, Florida Statutes, and by Chapter 25-22, Florida Administrative Code. Rule 25-22.016, Florida Administrative Code, states that the Commission will provide, upon written request, a public hearing for presentation of evidence, argument, and oral statements, within reasonable conditions, and limitations imposed by the Commission to avoid duplication, irrelevant comments, unnecessary delay, or disruption of the proceeding.

III. Procedures to be Followed

In order to ensure a full discussion and understanding of the issues, we request that participants send testimony or comments by September 12, 1989. The full Commission will participate in the rulemaking hearing. Send the testimony and exhibits to:

All prefiled testimony will be inserted into the record as though read after the witness has taken the stand and affirmed the correctness of the testimony and exhibits. Each witness will have an opportunity to summarize his or her testimony after being sworn in. All participants will have the opportunity to ask questions of the witnesses.


