Issue 16: Should FPL be required to refund these tax savings to customers?

Position: There are no tax savings due from the oil backout clause. The Company has collected excess revenues by using a 15.60% equity return in determining revenue requirements for the oil backout project. FPL should be ordered to refund all revenues collected through the oil backout clause resulting from the use of an equity return above the stipulated return of 13.60% (in the tax savings docket) from January 1, 1988 to date, with interest. (See discussion on Issue 6.)


