The Commission voted on 10/30/89 to transfer the attached rulemaking to a new docket. Thus, this is a request for a new docket number for the attached proposed rules. Previously, this was included in Docket 861190-PU.

However, in July, the Commission voted to bifurcate the docket and the rulemaking revisions. At that time they voted to propose rule revisions that would repeal the rule, Rule 25-14.003, for water and wastewater companies. They recommended that other revisions be brought back to them at a later agenda.

Those other revisions (the attached) were presented to them on October 30, 1989. At that time they voted to proceed with rulemaking also on these proposed rules.
