PURPOSE AND PROCEDURE

The purpose of this hearing shall be to allow Gulf Power Company to present its testimony and exhibits in support of its application for an increase in rates and charges; to permit Commission Staff and any intervenors to present testimony and exhibits concerning this matter; and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, and Chapter 25-22, Florida Administrative Code.

PURPOSE AND PROCEDURE

The purpose of these hearings shall be to permit members of the public to give testimony regarding the adequacy and quality of service rendered by Gulf.

At the hearings, customers of Gulf may be heard on any and all issues in the case relating to the proposed increases in charges or the quality of the company's services.

The procedure at the hearings shall be for the company to first present a brief summary of its case after which public witnesses will be allowed to present testimony. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

ADDITIONAL NOTICE

To insure that the public is made aware of the public hearings scheduled in this matter, Gulf has been directed to enclose in all customers' bills, prior to the hearings scheduled, a notice setting forth the dates and cities where the scheduled public hearings are to be held.

The company is also directed to publish in a newspaper of general circulation in its service areas and in areas affected by proposed changes, on two separate dates prior to the scheduled hearing dates, quarter page advertisements setting forth fully the times and places of the public hearings scheduled and the nature and scope of such hearings. The publications shall be made at least one week apart, the latter to be published no later than one week prior to the hearings. The advertisements and notices shall also advise the public that the Public Counsel will represent them, that he will meet with them prior to the hearing and how they may contact him by correspondence and by telephone prior to the hearings. Proof of publication of the notices shall be filed with the Commission prior to the commencement of the public hearings.

The notices shall advise the public that any issues relating to the rate increase, as well as quality of service may be raised at the public hearings.

PUBLIC COUNSEL

The Public Counsel, as authorized by Section 350.0611, Florida Statutes, has intervened in this docket on behalf of the Citizens of the State of Florida and will be present at the hearings to represent the public. He may be contacted prior to

the hearings at the Office of Public Counsel, c/o The Florida Legislature, 111 West Madison Street, Room 812, Tallahassee, Florida 32399-1400. The Public Counsel will be available to meet testifying members of the public one-half hour prior to the time the hearings are scheduled to begin.

JURISDICTION

Jurisdiction over Gulf Power Company is vested in the Commission by Chapter 366, Florida Statutes. Authority to approve any change in rates is governed by Section 366.06, Florida Statutes. This proceeding will be governed by the provisions of Chapter 120, Florida Statutes, as well as Chapters 25-6 and 25-22, Florida Administrative Code.
