SOUTHERN BELL TELEPHONE AND TELEGRAPH  
COMPANY'S MOTION FOR EXTENSION OF TIME

COMES NOW, Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.037, Florida Administrative Code, hereby moves the Florida Public Service Commission ("the Commission") for a thirty-day extension of time in which to submit applicable traffic studies in the above-referenced docket, and as grounds therefore states:

1. On February 16, 1990 the Commission issued Order No. 22567, which, among other things, requires Southern Bell to provide certain traffic studies applicable to the Mount Dora, Apopka, Orlando, Winter Garden, Winter Park, East Orange, Reedy Creek, Windermere and Lake Buena Vista exchanges in Orange County, Florida, by April 17, 1990.

2. Although Southern Bell began to conduct traffic studies immediately after receiving notice, this particular study required that Southern Bell manually record the calling pattern from Orlando to a pocket community of Mt. Dora located in Orange

County. Because the traffic study is being conducted manually, Southern Bell will not be able to complete the study by April 17, 1990. Thus, Southern Bell will not be able to comply in the time afforded to respond to Order No. 22567.

3. The requested extension will not prejudice any party to this proceeding and will facilitate a reasoned, informed decision by this Commission.

WHEREFORE, Southern Bell Telephone and Telegraph Company respectfully requests that the Commission grant it a thirty (30) day extension until May 17, 1990 in which to respond to Order No. 22567.
