REQUEST FOR HEARING


Comes now the Florida Police Chiefs Association and, pursuant to Chapter 120, Fla. Stats., respectfully request the Florida Public Service Commission to hold hearings concerning Southern Bell's tariff filing introducing Caller ID service. As grounds therefore, the Florida Police Chiefs Association states the following:

1. As described in the accompanying motion to intervene, Southern Bell's plans to introduce Caller ID service substantially affects the interests of the Florida Police Chiefs Association.

2. A disputed issue of material fact in this docket is the effect Southern Bell's tariff filing introducing Caller ID service would have on law enforcement activities within the State of Florida. This, in turn, raises the issue of whether Caller ID service, as proposed by Southern Bell, is in the public interest.

WHEREFORE, the Florida Police Chiefs Association respectfully requests the Florida Public Service Commission to hold hearings on Southern Bell's proposal to introduce Caller ID service in Florida.


