All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, and Chapter 25-22, Florida Administrative Code.

A prehearing conference in the above-referenced docket will be held at the following time and place:


