ORDER ACCEPTING \$10,000 FINE, CLOSING TWO DOCKETS AND LEAVING DOCKET NO. 891173-TS OPEN TO PROCESS THREE STS APPLICATIONS

BY THE COMMISSION:

On September 19, 1990, this Commission issued Order No. 23519 fining Sharenet, Inc., \$10,000 to satisfy a variety of outstanding obligations, including the \$500 fine levied by Order No. 22808, the \$3,400 fine amount proposed in show cause Order No. 22798, as well as the \$4,000 fine proposed in show cause Order No. 22894 for the Company's failure to timely file its 1989 Annual Report. The balance of the \$10,000 fine is for the Company's current operation without an interexchange (IXC) certificate. The Company was ordered to remit this fine within 30 days of our decision on August 21, 1990, or by September 20, 1990. In addition, the Company was required to file a completely acceptable IXC certificate application.

Sharenet, Inc., remitted the \$10,000 fine on October 16, 1990, which was 26 days late because the Company failed to begin

obtaining the necessary funds until the issuance of our Order No. 23519. However, because of the substantial amount of this fine and the short time frame for payment, we accept the \$10,000 fine amount. Therefore, Dockets Nos. 881346-TS and 890829-TP shall be closed, but Docket No. 891173-TS shall remain open to process the three STS applications that we had previously deferred by Order No. 22808.

Based on the foregoing, it is, therefore,

ORDERED by the Florida Public Service Commission that the \$10,000 fine amount submitted by Sharenet, Inc., is hereby accepted. It is further

ORDERED that Dockets Nos. 881346-TS and 890829-TP shall be closed. It is further

ORDERED that Docket No. 891173-TS shall remain open to process the three outstanding STS applications deferred by Order No. 22808.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice

should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
