Because Southern Bell is a local exchange company, which provides billing services for 976 providers and IXCs that carry 900 calls, any decision made by the Commission in the context of this proceeding will necessarily affect the substantial interests of Southern Bell and its business operations in the State of Florida.

WHEREFORE, Southern Bell respectfully requests that the Commission grant the Company leave to intervene for all legal purposes in this docket.
