



3. Applicant Florida Power & Light Company is a "Public Utility" incorporated in the State of Florida. Applicant Peace River Electric Cooperative, Inc., is a "cooperative" organized and

existing pursuant to Chapter 425, F.S. Applicants are subject to the Commission's jurisdiction as set forth in Section 366.04, F.S.

4. A Territorial Agreement exists between FPL and PRECO pursuant to Commission Order No. 18332. Applicants seek to modify Order No. 18332 by requesting approval of the Amendment attached hereto as Appendix I, and incorporated by reference herein.
5. The Amendment sought by this application proposes a modification of a portion of the territorial boundary between FPL and PRECO established by the Commission in Order No. 18332. Amendment Exhibit A of Appendix I shows the proposed FPL-PRECO territorial boundary modification along with the current territorial boundary. Amendment Exhibit B provides a written description of the proposed modification.
6. In accordance with Rule 25-6.0440 (1), items (a) through (e), F.A.C., FPL and PRECO provide the following information:
 - (a) Amendment Exhibits A and B. Amendment Exhibit A (attached to Appendix I) is a map which shows the proposed FPL-PRECO territorial boundary modification along with the current territorial boundary. Amendment Exhibit B (attached to Appendix I) provides a written

description of the proposed modification.

- (b) No modification of the terms and conditions of the previously approved Territorial Agreement is sought.
- (c) No customer transfers will be required or needed pursuant to the territorial boundary modification.
- (d) Since there are no affected customers to be transferred, items (d) and (e) of Rule 25-6.0440, F.A.C. are not applicable to this application. However, FPL has contacted the owner of the affected property. As a developer with plans for residential development, the owner of the affected property understands the reasons and implications of the boundary modification and concurs in the modification.
- (e) See (d) above.


- 7. The proposed territorial boundary modification is sought to allow the territorial boundary to conform to proposed development on and about the present boundary. Because of the particular nature of the development occurring along the portion of the territorial boundary sought to be modified

hereby, FPL and PRECO have agreed to a partial modification of the territorial boundary in order to avoid the inefficient use of facilities along the territorial boundary and improve safety.


8. Applicants represent that the proposed Amendment is in the best interest of the public.

WHEREFORE, the applicants request that the Commission issue an Order approving and adopting the Amendment to Territorial Agreement proffered hereby.


