



notify customers regarding their rights concerning billing for these services. Because GTEFL is a local exchange company, which provides billing services for 976 providers and IXCs that carry 900 calls, any decision made by the Commission in the context of this proceeding will necessarily affect the substantial interests of GTEFL and its business operations in the State of Florida.
