In most cases, delivery of mail between California and Florida is two working days.


Upon first notification by the Public Service Commission, my secretary was told that our filing was received on February 2, and the date has now has been changed to February 4.

All our Federal and State agency filings have deadlines by postmark and, as it turned out, the Florida Public Service Commission is the only exception. This puts an unfair burden on reporting companies, as the postal service is erratic in performance as is shown above.

This report was mailed from California with a January postmark, but did not arrive in the office of the Public Service Commission until February 2, 1991.


