Re: Docket No. 910170-TC - Initiation of show cause proceedings against AALL STATES TELEPHONE COMPANY for violation of Commission Rule 25-24.520, 1990 Annual Report, and Rule 25-4.043, Response Requirement.

Dear Mr. Weinstein:

We are in receipt of your 1990 Regulatory Assessment Fee Return Form, together with your request that your certificate be canceled. Unfortunately, because you failed to request cancellation of your certificate prior to the January 31, 1991 deadline for 1990 Annual Reports, a show cause docket has been opened against your company. Because this docket was opened prior to your request for cancellation, it must still be taken to Agenda. Normally, when we show cause a Pay Telephone Service (PATS) provider for failure to file an annual report, we allow them to voluntarily cancel in lieu of paying the recommended fine. In your case, I will treat this communication as a prefiled request for cancellation.

You will still receive a show cause order. This order will offer you several options, one of which will be voluntary cancellation. I will then take your letter back to Agenda and recommend to the Commission that you be allowed to voluntarily cancel your certificate. I realize this procedure seems hopelessly complicated. However, because a pending docket is already open, this will be the most expedient means of canceling your PATS certificate.

I must also inform you that you are still liable for the 1991 Regulatory Assessment Fee (RAF). You may or may not owe further RAF for 1990, depending on the particulars of your 1990 revenues. Because you held a PATS certificate during the first quarter of 1991, you are required to pay 1/8 of 1% of your total revenues. The minimum regulatory assessment fee is \$25.00. This minimum fee is applicable even if your total revenues total zero, or you were no longer providing PATS. Mere possession of a PATS certificate subjects you to this minimum requirement.
