Issue 1: Recommendation that the pay telephone service (PATS) providers referenced in the above dockets be required to show cause why the Commission should not fine each of them \$250 or, in the alternative, why these PATS providers should not have their certificates revoked for failure to comply with Rule 25-24.520, F.A.C., requiring annual reports, and Rule 25-4.043, requiring responses to Commission inquiries.

Issue 2: Recommendation that a fine of \$250 is an appropriate amount to be levied in lieu of certificate revocation for failure to file required reports and failure to reply to Commission inquiries.

Issue 3: Recommendation that these dockets remain open pending resolution of the show cause proceedings. However, the docket of any PATS provider that does not respond to the show cause order should be closed administratively upon expiration of the show cause response period and cancellation of certificates.
