ADDITIONAL NOTICE

To ensure that the public is made aware of the public hearing scheduled in this matter, City Gas Company of Florida, prior to the hearings scheduled herein, are directed to enclose in all customers' bills, or in a separate mailing to all customers, a notice setting forth fully the time and place of these hearings and a statement that "persons who wish to present testimony are urged to appear at the beginning of the hearing since the hearing may be adjourned early if no witnesses are present to testify". The notice shall be completed at least ten (10) days before the first scheduled hearing. The company is also directed to publish in a newspaper a general circulation in the area in which a hearing is to be held, a display advertisement stating the time, date, location and purpose of the hearing and a statement that, "persons who wish to present testimony are urged to appear at the beginning of the hearing since the hearing may be adjourned early if no witnesses are present to testify." The advertisements shall be published at least seven (7) days and are more than twenty (20) days before each service hearing.

JURISDICTION

Jurisdiction over this utility is vested in the Commission by Chapter 366, Florida Statutes; authority to approve any changes in rates is governed by Sections 366.04 through 366.0876, Florida Statutes. The provisions of Chapter 25-7 and 25-9, Florida Administrative Code, are also applicable.
