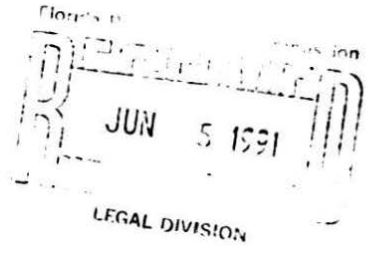

HILLSBORO CLUB, INC., by its attorneys and pursuant to the Order to Show Cause in the above-captioned proceeding and Florida Administrative Code Rules 25-22.036(7) (a) and 25-22.037(1), hereby responds to the Commission's Order to Show Cause regarding HILLSBORO CLUB, INC.'s failure to file an annual report with respect to its Pay Telephone Service, and states as follows:

- The respondent is HILLSBORO CLUB, INC. 901 Hillsboro Mile (AIA), Pompano Beach, Florida 33062.

2. HILLSBORO CLUB, INC.'s substantial interests will be affected in this proceeding by the Commission's order proposing to assess a fine against HILLSBORO CLUB, INC., or, alternatively, revoke its certificate to provide pay telephone services for failure to file an annual report with respect to such services by January 31, 1991.

3. The Order to Show Cause was issued on May 7, 1991, and responses were due by May 28, 1991. Pursuant to an extension of time granted by John Adams, Esq., attorney for the Commission, HILLSBORO CLUB, INC.'s response is due on June 3, 1991.

4. HILLSBORO CLUB, INC. intends to pay the \$250.00 fine assessed in the Order to Show Cause. A check in the requisite amount will be sent under separate cover to the Director of Records and Reporting for the Commission and will arrive by the close of this week.

5. HILLSBORO CLUB, INC. is constrained to point out, however, that its inability to timely file the required annual report resulted from the Commission's failure to provide the necessary form to HILLSBORO CLUB, INC. despite the latter's request. HILLSBORO CLUB, INC. paid the requisite minimum regulatory assessment fee for the second half of 1990 by check dated March 29, 1991 (see attached Exhibit A), in response to a notice which also referred to the unfiled report. At that time HILLSBORO CLUB, INC. requested another annual report form and was assured both that the form would be sent and that no further action would be taken against HILLSBORO CLUB, INC. because the fee had been

paid. The Commission's next communication with HILLSBORO CLUB, INC. was the Order to Show Cause in this proceeding.

6. HILLSBORO CLUB, INC. desires to continue providing pay telephone service and thus to maintain its certificate and its good standing with the Commission. HILLSBORO CLUB, INC. understands that, upon payment of the fine specified in the Order to Show Cause, this docket will be closed as to HILLSBORO CLUB, INC.


