SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S  
REQUEST FOR CONFIDENTIAL CLASSIFICATION AND  
MOTION FOR PERMANENT PROTECTIVE ORDER

COMES NOW Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, and Rule 1.280(c), Florida Rules of Civil Procedure, and files its Request for Confidential Classification and Motion for Permanent Protective Order regarding certain information provided to the Florida Public Service Commission ("Commission") Staff in response to its Second Request for Production of Documents in this docket.

1. On April 17, 1991, the Commission Staff served its Second Request for Production of Documents on Southern Bell in the referenced docket. On May 22, 1991, Southern Bell filed its response to the request, including a Notice of Intent to Request Confidential Classification. Consistent with the rules of the Commission, Southern Bell then provided to the Commission and the Staff, the responsive information including the material for which specified confidential treatment is now requested. accord with Rule 25-22.006, Florida Administrative Code, Southern Bell now files its Request for Confidential Classification and Motion for Permanent Protective Order for certain information contained in the responses provided to the Staff's Second Request for Production of Documents.

2. All of the information for which confidential treatment is sought reflects customer specific information, including the customer's name, address, telephone number, and, occasionally, other identifying information such as a "can be reached" number. Section 119.07(3)(w), Florida Statutes, clearly provides an exemption from public disclosure for such information, saying:

All records supplied by a telecommunications company to a state or local governmental agency which contain the name, address, and telephone number of subscribers are exempt from the provisions of subsection(1).

Consequently, under the cited exemption, the documents containing customer names, addresses and telephone numbers are exempt from disclosure in their entirety. However, in order to facilitate matters, Southern Bell has redacted the documents and herewith requests confidential treatment for only those materials which would identify the customer. The information for which confidential classification is requested is identified by page and line number in Attachment "A", an index of the documents. Appended hereto in a sealed envelope as Attachment "B" is a copy of the information with the confidential information highlighted. In addition, two edited copies with the confidential information deleted are appended hereto as Attachment "C".

3. In accordance with Rule 25-22.006, Florida Administrative Code, this information for which confidential treatment is sought is intended to be and is treated by the Company as private and has not been disclosed on a non-confidential basis.

WHEREFORE, Southern Bell respectfully requests that the Commission grant its Request for Confidential Classification and Motion for Permanent Protective Order.
