MOTION TO AMEND PREHEARING ORDER

COMES NOW Sailfish Point Utility Corporation, Petitioner for a rate increase in the above styled proceeding, and in support of its Motion states that:

1. The Prehearing Conference in this case was held in Tallahassee on June 6, 1991. On June 13, representatives of the Office of Public Counsel visited the Dallas accounting offices of Mobil Corporation for the purpose of viewing certain tax records. The result of that visit and the impact on the witness list in the Prehearing Order was left open at the Prehearing Conference. On June 17, OPC filed a request for production of documents based upon that visit to the Dallas accounting offices.

2. On June 21, simultaneously with the filing of this Motion, a response to the request for production was filed, producing documents identified in that Dallas visit.

3. As a result of this late discovery, the Utility moves for the amendment of the Prehearing Order to include, as Utility rebuttal witnesses, Mr. C. T. "Terry" Olson, and Mr. Steve Lopez, the Mobil Corporation employees who have custody and control of the tax records and who hosted the OPC representatives on their visit to the Dallas accounting offices.
