

MOTION FOR EXTENSION OF TIME

COMES NOW Sailfish Point Utility Corporation, Petitioner for a rate increase in the above styled proceeding, and states that:

1. At the final hearing held June 26-27, the Presiding Officer set Friday, July 5 as the date for the Utility to file Late Filed Exhibit #13.

2. Because of the intervening holidays and the unavailability of certain personnel during this time, it is not possible to complete the desired review and to provide Late Filed Exhibit #13 on the original time schedule.

3. The Utility requests a 4-day extension of time from Friday to Tuesday in which to file the exhibit.

4. On July 3 an attempt was made to contact the other attorneys in the case. The attorneys for OPC and for the Commission Staff have no objection to the extension. The attorney for SPOR was in a deposition and could not be reached. However, the substance of the motion was conveyed to his secretary.
