RE: AMENDMENT OF RULE 4.110, F.A.C., PERTAINING TO CUSTOMER BILLING - RULE HEARING, PHASE I, JULY 31, 1991

Timely requests for hearing were filed in this docket by GTE Florida, Incorporated, United Telephone Company of Florida and Sprint Gateways.

As previously announced, a hearing will be held on July 31, 1991, beginning at 9:30 a.m., in Room 122, Fletcher Building, 101 East Gaines Street, Tallahassee, Florida. The hearing will be conducted in accordance with the provisions of Section 120.54, Florida Statutes, and Rule 25-22.016, Florida Administrative Code. All affected persons may present evidence and argument on the proposed amendments to Rule 25-4.110, subsection (1)(a), as published in the Florida Administrative Weekly on May 10, 1991, and in the Commission's Notice issued May 6, 1991. Hearing participants should note that this proceeding concerns only the currently proposed amendments of the rule and is not intended to address any issues which may relate to the further amendments of the rule to be proposed in Phase II of these proceedings. Prefiling of testimony and exhibits is not required.

The petitions filed by GTE Florida and United Telephone raise issues concerning the feasibility of immediate implementation of the billing changes proposed in the rule amendment, the accuracy of the cost estimates contained in the Economic Impact Statement and the need for a mechanism to recover the true costs resulting from the rule amendment. Sprint Gateways raises the issues of whether it is necessary to segregate 900/976 charges on customer bills and whether bills should indicate that there will be no disconnection for nonpayment of any nonregulated charge. To facilitate an expeditious and orderly hearing, any person wishing to raise other specific issues should submit them to the Hearing Officer by July 24, 1991, and serve a copy of the proposed issue upon all persons listed on the attached service list.
