BEFORE ME, the undersigned authority, personally appeared J. L. Richardson, who being first duly sworn, deposes and says: That he occupies the position of President of TRITON, Incorporated and states as follows: Happy Stores #510, located in Bay County, Florida, will be exempt from the regulation of the Florida Public Service Commission pursuant to Section 367, Florida Statutes, for the following reasons.

1. TRITON, Incorporated owns and operates a non-community public water system.
