By Order No. 24638 issued June 7, 1991, in Docket No. 910097-WS, Certificates Nos. 524-W and 459-S were transferred from Century Group, Inc. to BDC, Inc. in Pasco County. The utility has contacted staff requesting acknowledgment of a name change to BDC, Inc. d/b/a Timberwood Utilities. The purpose of the name change is to separate the utility business from the other functions of BDC, Inc., which owns the mobile home park served by the utility. The utility has submitted a copy of a Notice of Intention to Register Fictitious Name which appeared in the Zephyrhills News on August 1, 1991. In addition, the utility has filed revised tariffs reflecting the new name of the utility. Please prepare an administrative order acknowledging the name change within twenty days.
