WHEREAS, Volusia County residents have continually expressed great interest in toll-free calling throughout the County; and

WHEREAS, a great percentage of the County population and businesses are located in the eastern plain and the County-seat of government is located in the western portion and

WHEREAS, there is a significant community of interest from most points in the County to most others; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNTY COUNCIL OF VOLUSIA COUNTY, FLORIDA, IN OPEN MEETING DULY ASSEMBLED IN COUNTY COUNCIL CHAMBERS IN THE VOLUSIA COUNTY ADMINISTRATION BUILDING, DELAND, FLORIDA, THIS 13TH DAY OF JUNE, A.D. 1991, AS FOLLOWS:

SECTION I: That the State of Florida Public Service Commission is hereby requested to study the possibility of toll-free calling within Volusia County and advise our residents of the ramifications involved. If total County-wide toll-free calling appears cost prohibitive, it is requested that options be presented to markedly improve toll-free calling within the County.

SECTION II: This Resolution shall take effect immediately upon adoption.
