

REQUEST FOR EXTENSION OF TIME

ALLTEL Florida, Inc. ("ALLTEL") files this its Request for Extension of Time within which to implement the 25¢ calling required by Order No. 25566 issued on January 6, 1992 for the two Brooker routes listed in that Order and says:

1. Order 25566 issued January 6, 1992 provides that within six months the date Order 25566 becomes final the 25¢ calling plan must be implemented between Brooker (served by ALLTEL) to Starke (served by Centel) and Brooker to Lawtey (also served by Centel).


2. Since ALLTEL's Brooker exchange will not become digital until September 1992 ALLTEL hereby requests an [sixty day] extension to October 1, 1992 to implement the 25¢ calling plan on the two Brooker routes. Digital equipment is needed to measure usage for local message rate service ordered by the Commission.

3. Under Order No. 25566, 25¢ calling plan must be implemented on the aforementioned routes by July 27, 1992 or six months from the expiration of the protest period set forth in that Order. Consequently, ALLTEL requests until October 1 within which to implement the aforementioned routes.

WHEREFORE, ALLTEL requests an extension of time to October 1, 1992 within which to comply with the provisions of Order No. 25566.


