COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files this Withdrawal of their Notice of Intent to Request Specified Confidential Classification originally filed on May 22, 1992.

1. On April 17, 1992, the Florida Public Service Commission Staff ("Staff") filed its First Request for Production of Documents. Southern Bell filed its responses and objections, along with a Notice of Intent to Request Specified Confidential Classification on May 22, 1992.

2. The material contained in the documents that Southern Bell produced which was confidential and proprietary business information was redacted as irrelevant under Rule 1.280, Florida Rules of Civil Procedure prior to delivery to the Staff.
