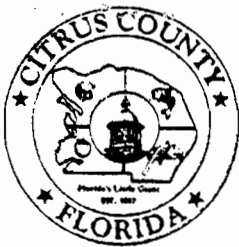

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CITRUS COUNTY, FLORIDA, IN SUPPORT OF A LOCAL PUBLIC HEARING OF THE FLORIDA PUBLIC SERVICE COMMISSION IN REGARDS TO THE SOUTHERN STATES UTILITIES RATE ADJUSTMENT REQUEST.

WHEREAS, Southern States Utilities, Inc. provides water and sewer service to eleven communities within Citrus County; and

WHEREAS, those eleven communities make up a large portion of the residents of Citrus County who are dependent upon the State of Florida Public Service Commission to protect them in the regulation of water and sewer rates; and

WHEREAS, Southern States Utilities, Inc. customers in Citrus County are paying substantial water and sewer rates; and

WHEREAS, Southern States Utilities, Inc., has filed a petition with the Public Service Commission to increase water and sewer rates to some of its Citrus County customers; and

WHEREAS, a large increase in water and sewer rates would work a financial hardship on residents of Citrus County inasmuch as a large number of retired citizens on fixed incomes live in those eleven communities;

NOW, THEREFORE, BE IT RESOLVED, by the Citrus County Board of County Commissioners as follows:

1. That the State of Florida Public Service Commission hold a public hearing in Citrus County due to the fact that many residents of this County will desire to make their opinions known to the Public Service Commissioners before a judgement is made on this request.

2. The Clerk of the Board is hereby directed to send a certified copy of this resolution to the Florida Public Service Commission.
