SOUTHERN STATES UTILITIES, INC. and DELTONA UTILITIES, INC. (hereinafter referred to collectively as "Southern States") and the OFFICE OF PUBLIC COUNSEL ("the Citizens"), jointly request the Prehearing Officer to grant a ten (10) day extension of time for the submission of prepared direct testimony by Intervenors and Staff, and prepared rebuttal testimony by Southern States. 


