Consequently, because these documents contain proprietary information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to take possession of the documents without delay. The original of this notice and copies of the staff requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
