Dear Mr. Barth:

This letter is to confirm our telephone conversation on
September 3, 1992, that you are in the process of retaining an
attorney for the above-referenced docket. During our conversation
you also requested that you be given until October 1, 1992, to
either file an application for a certificate or a revised
application to become exempt from Commission jurisdiction under a
different arrangement that staff recommended be denied for
exemption at the April 21, 1992, Agenda Conference.

As you may recall, by letter dated May 14, 1992, staff
informed Stewart/Barth Utility that it would have 90 days to either
file an application for a certificate or file for an exemption
under some revised circumstances or staff would recommend
appropriate action. Although staff has already given Stewart/Barth
approximately four months to decide what action it will take in
this proceeding, we will delay filing any recommendation until
October 1, 1992, by your request. However, if the necessary
information for an exemption or an original certificate is not
filed by October 1, 1992, staff will file a recommendation on
October 8, 1992, (to be heard by the Commission at the October 20,
1992 Agenda Conference) recommending that the Commission initiate
a show cause proceeding. If the Commission decides to do so,
Stewart/Barth would be required to show cause why it should not be
fined for operating without a certificate.


