1. The Staff of the Florida Public Service Commission ("Staff") has issued Audit Request No. 36 in the above-captioned docket, requesting, among other things that Southern Bell make available for viewing the following information:

2. Source documentation for certain intercompany billings, including journal entries, invoices, vouchers, and contracts.

3. Some of the information contained in the responsive documents to be reviewed by the Staff is clearly proprietary. For example, some of the documents and data contain information on non-regulated affiliates and activities, settlement information, customer-specific information, employee-specific information unrelated to compensation, other states' information and vendor-specific information. This information is entitled to proprietary and confidential treatment under Florida law and
