COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and, pursuant to rule 25-22.006(3)(a), Florida Administrative Code, files its Notice of Intent to Request Confidential Classification for certain documents or portions of documents to be provided in response to Staff audit requests.

1. The Staff of the Florida Public Service Commission ("Staff") has issued Audit Request Nos. 34, 55, CAM-13 and CAM-20 in the above-captioned docket, requesting that Southern Bell make available for viewing certain documents, as more specifically described in the Staff audit requests. These documents include internal audits and documents containing information relating to Southern Bell's unregulated products and services.
