COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and, pursuant to rule 25-22.006(3)(a), Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued Audit Request Nos. 49, 57, CAM-9 (Item No. 6) and CAM-22 in the above-captioned docket.

2. Some of the information provided or contained in the responses or responsive documents to be reviewed by the Staff is clearly proprietary. For example, some of the documents and data contain financial and other information on non-regulated activities, internal audit information and reports, customer-specific information, employee-specific information unrelated to compensation, duties, qualifications and responsibilities, other states' information and Company-specific proprietary information contained in workpapers of third party auditors. This information is entitled to proprietary and confidential treatment under Florida law and Commission rules. Section 364.183, Florida Statutes; Rule 25-22.006, Florida Administrative Code.


