LIN OPC DOCKET NO. 920853-WU; REQUEST FOR EXEMPTION FROM FLORIDA PUBLIC SERVICE COMMISSION REGULATION FOR PROVISION OF WATER SERVICE IN BRADFORD COUNTY BY MORGAN ROAD BAPTIST CHURCH PURSUANT TO SECTION

367.021(12).

On July 6, 1992, the Board of Bradford County Commissioners adopted a resolution declaring Bradford County subject to the provisions of Chapter 367, Florida Statutes (FS). The resolution was acknowledged by this Commission on September 9, 1992 by Order No. PSC-92-0959-FOF-WS. Pursuant to Section 367.031, FS, a utility subject to the jurisdiction of this Commission must obtain a certificate of authorization or an order recognizing that the system is exempt from Commission regulation.

On August 25, 1992, this Commission received an application from Morgan Road Baptist Church for non-jurisdictional status as provided for in Section 367.021(12), FS. The mailing address for Morgan Road Baptist Church and the ACK location address of the water system is Route 5, Box 7751, Starke, Florida, 32091. The contact person is Mr. Joseph J. Lamb. The applicant operates a water system which provides water service to the members and guests of the church without compensation. Wastewater service is provided by a private septic tank located on site.

 The application was filed by Mrs. Margie Lamb, church secretary, on behalf CANIL of Morgan Road Baptist Church in accordance with Section 367.021(12), Florida Statutes, and Rules 25-30.060 (1), (2) and (3)(j), Florida Administrative Code. EAG The applicant indicated that they provide water service solely to the members and guests of the church without compensation and that all costs for providing such service are treated or recovered as operational expenses. Furthermore, they -acknowledged Section 837.06, FS regarding false statements.

According to Section 2.08 (C)(14), Administrative Procedures Manual, staff RCH -has been given administrative authority to approve clear-cut or non-controversial I requests for determination of exempt status. Staff recommends that an administrative order be issued within 30 days of the date of this memorandum finding Morgan Road Baptist Church a non-jurisdictional entity pursuant to Section 367.021(12), Florida Statutes. Staff further recommends that the order require Morgan Road Baptist Church to notify this Commission in the event the operation of their water system changes. Furthermore, staff recommends that this docket be closed.
