ORDER INDICATING NONJURISDICTIONAL STATUS
OF TREASURE COAST CHURCH OF GOD AND CLOSING DOCKET

BY THE COMMISSION:

On January 4, 1993, Treasure Coast Church of God (Treasure Coast) filed an application with this Commission for recognition of its nonjurisdictional status, pursuant to Section 367.021(12), Florida Statutes. Treasure Coast is located at 4050 S.W. Savona Boulevard, Port St. Lucie, Florida, 34952. Reverend Ray Franklin filed the application on behalf of Treasure Coast.

Section 367.021(12), Florida Statutes, states that a "utility means a water or wastewater utility and except as provided in Section 367.022, includes every person, lessee, trustee, or receiver owning, operating, managing or controlling a system, or proposing construction of a system, who is providing or proposes to provide water or wastewater service to the public for compensation."

Upon request and sufficient proof, the Commission will issue an order indicating the nonjurisdictional or exempt status of water or wastewater systems if they qualify under the appropriate provision of Chapter 367, Florida Statutes. The application was filed in accordance with Section 367.021(12), Florida Statutes, and Rules 25-30.060(1), (2) and (3)(j), Florida Administrative Code. Treasure Coast requested nonjurisdictional status for the provision of water and wastewater. Treasure Coast, a non-profit corporation, provides water and wastewater service only for the church. Water service is provided by a well. Wastewater service is provided by private septic tank. Water and wastewater service is provided to the church at no charge, and all costs of providing service are treated or recovered as operational expenses.

In addition, the application form states that pursuant to Section 837.06, Florida Statutes, anyone knowingly making a false statement in writing with the intent to mislead is guilty of a misdemeanor. Treasure Coast acknowledged that it is aware of

Section 837.06, Florida Statutes, and the penalties for making false statements in the application.

Based on the facts as represented, we find that Treasure Coast is not a utility pursuant to the provisions of Section 367.021(12), Florida Statutes. However, should there be any change in circumstances or method of operation, Reverend Ray Franklin or any successor, must inform the Commission within 30 days of such change so that we may review the matter to determine whether nonjurisdictional status is still appropriate.


It is, therefore,

ORDERED by the Florida Public Service Commission that, based upon the facts as represented, Treasure Coast Church of God, P.O. Box 8776, Port St. Lucie, Florida, 34952, is not a utility subject to this Commission's jurisdiction, pursuant to the provisions of Section 367.021(12), Florida Statutes. It is further

ORDERED that should there be any change in circumstances or method of operation, Reverend Ray Franklin or any successor in interest, shall inform this Commission within 30 days of such a change so that we may re-evaluate the Center's nonjurisdictional status. It is further

ORDERED that Docket No. 930013-WU is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
