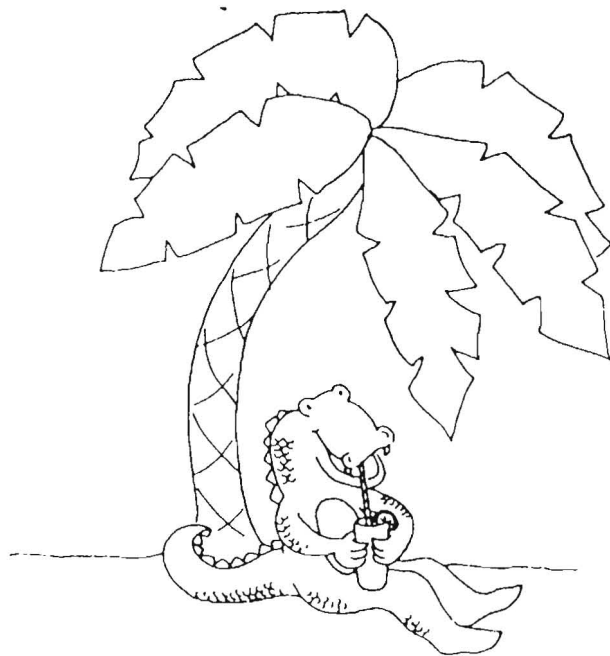

Dear Senator Dantzler:

You requested information regarding the calling scope and telephone service of a community called Polo Park. Polo Park is located in the Haines City exchange. As detailed in the letter by Ms. Joan Lehman, this community is in Polk County but is also on the county lines of three other counties (Orange, Lake and Osceola). The local calling scopes for the surrounding exchanges vary vastly due to geography and different communities of interest.

Because city, county and exchange lines often differ, consumers within one exchange could have a different calling scope of a customer located one mile away due to exchange boundary lines. Exchange boundaries were initially drawn to enable a telephone company to provide service in the most efficient and economical way from the nearest available facilities. Over time, the communities in these exchanges have grown and developed community of interests with contiguous areas, which explains the difference in calling scopes between exchanges. The Commission has over time implemented extended area service (EAS) between exchanges that have exhibited strong calling patterns and communities of interest.

In the case of Ms. Lehman, she believes she is being penalized since her exchange (Haines City) only has local calling to Kissimmee and West Kissimmee compared to Winter Garden, West Kissimmee exchanges and other nearby cities, who are able to call large cities such as Orlando and Buena Vista.

In order for the Commission to consider an EAS request, one of the rule requirements listed below must be met:

1. A petition signed by at least five (5 %) percent, but not less than fifty (50), of the subscribers in the exchange from which the petition originates, or

2. A petition/resolution adopted and filed with the Commission by the governing body of the political subdivision.


If there is enough interest in the Haines City exchange to expand the local calling scope to other exchanges, the Commission will review the request and determine if it qualifies under our rules for nonoptional, flat rate, two-way EAS.

All requests for EAS, regardless of how initiated, must state the name of the originating exchange and the name of the exchange(s) to which EAS is sought. Once this information is received by the Commission, the Commission will order the local exchange company to conduct a traffic study. If the traffic study indicates that the calling volume and the distribution of the calling patterns qualify under our rules, the Commission will order the route(s) to be balloted for flat rate EAS.

You also wanted to know if we have had any requests or contacts regarding this area. The only request we have had that involves this area was in Docket No. 920097-TL, which was an EAS request by Frostproof for EAS to Bartow, Haines City, Indian Lakes and Winter Haven. The routes exhibited very low calling volumes and did not meet Commission rules to qualify for EAS. It should also be noted that in General Telephone Company (GTEFL) Rate Case, staff determined that there was not sufficient calling volumes on any of the intra-county routes in Polk County to implement any kind of toll relief. We have not had any requests for EAS from the Haines City exchange into other exchanges outside of GTEFL's service territory.
