Dear Edie,

As we discussed by telephone recently, Turkey Creek Utilities has begun refunding security deposits to various homeowners. This action brings up several questions.

I have not received a refund, so I am enclosing a copy of the bottom part of the check sent to Charles Specht, one of our Board members. Mr. Specht received a \$60.00 check when his deposit was \$100.00. The enclosed form establishes the amount of his deposit. Mr. Hope refunded the money without any explanation other than the statement "utility deposit refunded". In fact, what has been received is a partial refund. I understand that a similar amount has been deducted from the other refunds that have been paid out. Our concerns and questions:

- l If only a partial refund is being sent out, doesn't the utility have an obligation to fairly and fully inform its customers that they are not receiving a full refund and that part of the deposit in being retained?
- 2 Are we entitled to interest on the deposit from the time the PSC obtained jurisdiction?
- 3 Will we receive interest on the retained amount?
- 4 When will Mr. Specht and the other customers receive the balance of their deposits?

I would appreciate your review of this matter.

4. I am not to remeter, resell, allow to be used on another property or residence, any after obtained from Turkey Creek, Inc., and that I will not allow other water to be connected with the water system of Turkey Creek, Inc.

5. User agrees not to tamper with, damage or destroy, any seals, material, or equipment of

Jurkey Creek, Inc.

6. All payments for said water services shall be made in person or by mail at the office

of Turkey Creek, Inc., in Alachua County, Florida.

- 7. I am not to use any water, except as approved in writing by Turkey Creek, Inc., on or in connection with the above premises which is not furnished or supplied by Turkey Creek, Inc., or its successors, designees, nominees or assignees.
- 8. I will not allow any water or waste, except human waste generated in my residence, to enter the wastewater system of Turkey Creek, Inc., unless said water or wastewater has been metered and/or sold by Turkey Creek, Inc.

9. Water from a well, stream, lake or basin may be used only for the purpose of watering

grass, shrubs, gardens, and as approved in writing by Turkey Creek, Inc.

10. A designated official from Turkey Creek, Inc., may inspect my water or wastewater system on my property at any reasonable hour to determine compliance with this application. I further understand that if I am not complying with all conditions on this application, that my matter and wastewater service will immediately be cut off and discontinued without notice.

11. Water service can be discontinued and the application voided during normal business cours of Turkey Creek, Inc., upon notification by the applicant to the utility and payment of current billing.

12. Water service connections, disconnections or reconnections at the customer's request vill only be done upon 24 hours notice and during normal business hours of Turkey Creek, Inc.

Thereby agree to pay the rates and obey/follow rules as may be set or amended from time to time by Turkey Creek, Inc.
