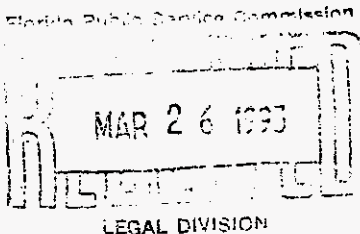
Petitioner, Southern Bell Telephone and Telegraph Company,
